Real Estate Transactions and Financing

The Firm's real estate tax specialists are regularly instructed with regard to operations concerning proprietary rights: conveyances of land, construction works, sales of buildings or real estate companies, separation of the various attributes of ownership, vesting rights of possession or rights to benefits, rents and profits from real property, finance leasing, etc. Its role is to propose an optimum tax environment for clients' transactions.

It also administers major real estate assets in France and abroad and has developed specific skills in offering clients the most appropriate solutions for holding, selling, purchasing and leasing buildings owned directly or indirectly through corporate entities.
