

COVERED BONDS

Licensing Approval Procedure

As part of the procedure for licensing approval of the *Autorité de contrôle prudentiel et de résolution*, Gide offers the group sponsor and the arranger its experience on the content of the application file for the approval of the SCF/SFH to be provided to the *Autorité de contrôle prudentiel et de résolution*, the incorporation documents, the corporate governance and authorised outsourcing arrangements, as well as the specific requirements of regulatory authorities for SCF and SFH.

Issuance Programme

In the context of the setting up and maintenance of an issuance of covered bonds, the firm has advised the group sponsor and the arranger drawing on its experience of the specific requirements of the competent market authorities and of market practices for issuance programmes for real estate and mortgage-related bonds, in particular on the inclusion of American options 144a and 3(a)(2), and/or of German and Australian options.
