Our lawyers have significant expertise in all stages of oil and gas exploration and production projects in France, from licence applications to assistance for work declarations and environmental authorisations, as well as structuring, securing and implementing hydrocarbons assets acquisitions.

We also provide legal advice to natural gas suppliers and traders on their regulatory and administrative issues and their contractual relationships with all stakeholders in the natural gas market. We assist major international oil companies and new market players alike.

Our Areas of Expertise

- **Applications for hydrocarbons exploration and production licences:** legal assistance to international oil companies regarding applications for exploration and exploitation licences in France, and negotiations with local and national authorities.
- **Acquisition of interests in hydrocarbons licences:** legal due diligence of hydrocarbons assets, structuring of sale and purchase transactions, assisting clients in non-opposition and/or mutation processes.
- **Drafting and negotiating ancillary hydrocarbons contracts:** joint operating agreements, joint venture agreements, shareholders' agreements, drilling and services agreements, off-take agreements, farm-in and farm-out agreements.
- **Authorisations to supply natural gas:** regulatory framework applicable to the energy market and, in particular, to the supply of natural gas, legal advice to natural gas companies on their applications for administrative authorisations to supply natural gas, assistance in discussions with the French administration.
- **Access to natural gas facilities:** access to LNG terminals, access to storage facilities, interconnection with transmission/distribution networks.
- **Natural gas and LNG trading:** drafting of suppliers' general terms and conditions of sale (to other suppliers or to industrial clients) and single supply contracts, mostly on the basis of model contracts (EFET® or AIPN® models).
- **Securitisation on hydrocarbons assets:** securities over natural gas stocks and natural gas streams.

Hydrocarbons Exploration and Production

- **Shale Gas / Paris basin (ongoing)**: assisting a US oil & gas company in its application for eight exploration permits for shale gas in the Paris basin.
- **Farm-in agreements (ongoing)**: assisting a UK company in the acquisition of participating interests in two exploration permits for hydrocarbons (shale gas) in the south of France.
