### An International Network

- Handling enforcement of judgments and awards.

## Dispute Resolution - Main Areas of Expertise

### Arbitration

The Arbitration team is made up of lawyers from a variety of backgrounds and cultures and has globally recognised expertise handling cases under all the leading arbitration rules and institutions. The team acts for private companies, public enterprises, and States, advising on litigation strategy and handling the entire arbitral process.

### Insurance, Industrial Risk & Transport

The Insurance team assists the Gide's clients in a number of business sectors and various types of proceedings: insurance pre-litigation and crisis management, life and non-life insurance litigation, regulatory and insurance product distribution litigation, and alternative claims dispute resolution methods.

### Banking & Finance

The team includes specialists in banking and finance law as well as criminal and commercial litigation who are experts in handling the complex issues in this field and in representing the firm's clients before disciplinary and civil courts.

### Competition

The team advises and represents clients in all areas of competition litigation. ### Public Law & Environment

The Public Law team regularly advises and represents clients before all administrative courts. Our lawyers are also frequently instructed in emergency proceedings and represent clients in disputes relating to the management of public legal bodies and the status of their executives.

In environmental matters, our specialist lawyers represent clients before the administrative and civil courts (disputes concerning classified facilities, criminal and indemnity proceedings).

### Tax

The Tax team assists companies and individuals responding to tax inspections, in the pre-litigation process, and before the administrative and civil courts in disputes concerning all principal forms of taxation.


