In another cross-border highlight, the team advised Veolia Environnement on the first issuance of a panda bond by a French issuer. Domestic highlights include advising Europear Groupe on the issuance of 144A high-yield senior notes. Other clients include Société Générale, Gecina and BNP Paribas. Practice heads Arnaud Duhamel, Hubert Merveilleux du Vignaux and US-qualified Melinda Stege Arsouze are the key names. »

In capital markets the team is particularly strong in the areas of structured finance and securitisation, and debt. In debt the firm acts on various products including all types of vanilla, private placements, hybrid, high yield and covered bonds. A significant transaction saw the team work for Bank of America Merrill Lynch as the underwriter of two US dollar bond offerings by electricity company EDF, one a \$3.5 billion senior bond issue of four tranches, and one a \$1.25 billion green bond issue. Elsewhere the team acted for CNP Assurance on its issuance of €750 million subordinated notes due 2047 on to the Euronext Paris.

The practice is also active in equity, an example deal highlight is work for GenSight Biologics, a French biotechnology company, on its IPO by means of an offering of American depositary receipts (ADRs) on to the Nasdag.»
