
The two offices work together seamlessly to provide clients with a unique national and European expertise, notably in view of their in-depth knowledge of the workings and procedures of the European institutions.

### A Significant Practice in State Aid Matters

State aid rules are increasingly impacting several fields of law. The different forms of financing (subsidies, bail-outs, public loans, tax relief, etc.) that governments grant to companies may distort competition and should therefore, under certain circumstances, be referred to the European Commission for approval.

Gide has extensive experience advising governments and companies across a wide range of sectors in both formal and informal State aid investigations. Our lawyers have built up cutting-edge expertise in this area, notably in:

- checking the **legality** of State aid that our clients (or their competitors) may receive. For example, Gide advised a consortium in its negotiation with an Eastern Europe Member State in order to ensure compliance of a **large motorway project** with both EU State aid and concession rules. Gide also advised the French investments agency (APE) in the context of the privatisation process of two airports (Nice and Lyon) notably to ensure its compliance with State aid rules.
- preparing **notification** of aid measures to the European Commission. For example, Gide assisted **Kem One**, active in the vinyl sector, on the notification of a State aid for restructuring, granted by the French government, and obtained a positive decision.
- lodging a **complaint** before the European Commission. Gide is notably assisting **Westbahn** in the context of a complaint that it lodged against Austria for illegal State aid granted to a **railway operator** as part of a concession.
- representing clients in the context of **formal investigation procedures** opened by the European Commission. Gide recently advised an **electricity producer in the Baltic area** on all State issues concerning electricity and energy production and obtained a positive decision for this client.
- representing clients' interests **before the EU and national courts** when the legality of State aid is challenged. Gide has notably assisted **France Telecom (Orange)** in several annulment proceedings concerning decisions of the European Commission.
- assessing how to combine State aid with other funding, such as **EU Funds, EIB, and EBRD**. Gide is assisting several clients including IFIs in this regard.

## Selected State Aid Expertise in Poland

- **PLL LOT** - Advising LOT in the formal investigation procedure opened by the EU Commission on restructuring State aid. A positive decision was adopted in 2014.
- **Polfa Tarchomin** - Advising on the principles of granting State aid during the privatisation process.
- **City of Warsaw/ERDF State aid and Concession** - Advising the City of Warsaw on a large project financed by ERDF in water treatment to ensure compliance with EU structural funds as well as Concession and State aid rules.
