#### Insurance

They work in close cooperation with the Customs Authorities to prevent and pursue infringements of intellectual property rights and contribute to the trainings of public servants.

Gide Turkey's lawyers also carry out procedures relating to objections, transfers and registration of trademarks and designs before the Turkish Patent Institute. Additionally, our team regularly advises companies and IT operators on licensing issues and Internet/technology legislations.

## Competition Law - International Trade

Our activities in Competition Law mainly consist in: prior approval notifications to the Competition Board for mergers and acquisitions, setting up of distribution/dealership/franchise networks and compliance analysis of existing ones, as well as applications to the Competition Board for exemption and negative clearance. Gide Turkey also provides legal assistance at all stages of preliminary examinations and investigations initiated by the Competition Board against horizontal agreements between competitors and cartels.

## Tax, Exchange Control and Customs
